 - 1. International treaties of Ukraine ratified by the Verkhovna Rada of Ukraine shall be part of the national law and shall apply in the same manner as the rules of the national law.
 - 2. If an international treaty of Ukraine, which has duly entered into force, sets forth other rules than those provided for by the relevant act of the Ukrainian law, the rules of the international treaty shall apply.
- Articles 15, 16, 17, 18 provide that international agreements and treaties must be duly followed and implemented by all Ukrainian agencies and that the Foreign Ministry monitors the implementation and may request the President or the Cabinet of Ministers to take steps to prevent non-compliance with an international treaty.

- 1. If the international agreement of Ukraine, ratified by Verkhovna Rada, envisions the different procurement procedure than the procedure, defined by this law, <u>the procedures of the international agreement</u> of Ukraine shall be applied.
